

Annex C: Risk Assessment Checklist for Pesticide Use and Producer Health

This checklist is designed to assess risks associated with pesticide use and its impact on producer health, particularly in alignment with the Standard's requirements under the Health and Safety theme and Integrated Pest Management (IPM) requirements.

- If all answers are "No", the farm is at low risk for common pesticide-related health and safety issues.
- If any question is answered "Yes", this indicates the presence of a risk. In such cases:
 - o It might be a non-compliance with one or more requirement of the SRP Standard for Sustainable Rice Cultivation
 - o Immediate mitigation measures should be implemented
 - Producer training should be conducted, focusing on the identified risks and emphasizing corrective actions to ensure safety.

This checklist is a tool to guide improvements in farm management practices and safeguard producers and community health.

1.	Are pesticides used that are banned internationally or locally, or listed on any of these following international lists:

	List of banned pesticide is compiled based on the three international lists, as referenced in annex E. This ensures alignment with globally recognized safety and environmental standards.

3.	Are pesticides purchased from unauthorized or unlicensed suppliers?		
4.	Are any pesticides being used on the farm that are not registered and approved for use on rice crops?		
5.	Do producers fail to document the active ingredients, amounts of pesticides, pre-harvest intervals (PHI) and pesticide application dates?

6.	Have producers and applicators failed to receive pesticide safety training in the last three years?		
7.	Are producers unaware of the risk pesticides pose to women and children?		
8.	Are women producer member and family member excluded from pesticide safety training programs?		



Sec	tion C: Preventive Measures for Pest Management	
9.	Are pests NOT monitored regularly to assess their population before applying pesticides?	
10.	Are non-chemical pest control methods (e.g., biological controls, cultural practices, traps) NOT implemented before resorting to pesticides?	
11.	Are thresholds for pest damage NOT established or followed before deciding on pesticide application?	
12.	Are natural predators (e.g., beneficial insects) NOT protected or encouraged to reduce pest populations?	
Sec	tion D: Protective Measures & Safe Handling Practices	
13.	Are applicators applying pesticides without adequate protective equipment (e.g., gloves, masks, goggles, boots)?	
14.	Is the protective equipment poorly maintained or unavailable?	
15.	Do applicators fail to read the pesticide label before using it?	
16.	Are pesticides applied/handled by pregnant or lactating women, persons under 18 years old, or individuals with chronic or respiratory diseases?	
17.	Are pesticide-contaminated clothes or containers being washed by pregnant or lactating women or by children under 18 years old?	
18.	Are pesticides mixed without proper tools (e.g., measuring cups) or under unsafe conditions?	
19.	Is pesticide equipment cleaned in household areas or near water sources?	
Sec	tion E: Storage and Disposal	
20.	Are pesticides stored in open or unlocked areas accessible to children, food, feed or water?	
21.	Are empty pesticide containers reused?	
22.	Are pesticide containers or waste disposed of improperly (e.g., burned, buried unsafely, or dumped)?	
Se	ction F: Health Monitoring and Community Safety	
23.	Are applicators NOT undergoing regular health checkups to monitor for pesticide-related health effects?	
24.	Are first aid kits unavailable in areas where pesticides are used?	
25.	Are producers and applicators unaware of emergency procedures in case of pesticide exposure?	
26.	Are children exposed to areas where pesticides are sprayed, mixed, or handled?	
27.	Are pesticides transported together with food, water, or passengers?	
28.	Are warning signs NOT posted to restrict entry into pesticide-treated areas until the re-entry interval has passed?
